**MADALENA ANNOUNCES PLANS FOR COMPLETION OPERATIONS ON ARGENTINA
EXPLORATION WELL**

Madalena Ventures Inc. ("Madalena" or the "Corporation") is pleased to announce that the exploration well currently being drilled on the Coiron Amargo Block in the Province of Neuquen, Argentina has been drilled to total depth ("TD") of 3353 meters and has been cased to TD. The Corporation has identified two separate zones with hydrocarbon potential and is presently moving completion equipment onsite to perforate and adequately test the potential productivity from the two zones. The Corporation anticipates the testing operations will be completed prior to the end of February, 2009.

Madalena is a publicly traded international junior Canadian oil and gas exploration company trading on the Toronto Venture Stock Exchange under the symbol "MVN". The Company has assets in Canada, Tunisia and Argentina and is actively evaluating international oil and gas opportunities with a primary focus on South America and North Africa.
